Dedicated partner scholarships awarded to students from The University of Lima, Faculty of Business and Economics studying an undergraduate program within Business, Commerce or Economics.

Award value

- Up to five (5) 25 per cent tuition fee waivers towards the UQ enrolled program.
- Priority access to exciting programs offered by the Student Employability Team.
- Receive exclusive invitations to selected seminars, presentations and events throughout your studies.
- Join a network of Global Leaders Scholarship alumni upon graduation, and build on professional networks at home and abroad.

Eligibility

- A 25 per cent tuition fee reduction is available for eligible students from The University of Lima who commence an approved credit transfer pathway at The University of Queensland (from July 2022) for the duration of their studies (up to 16 courses).
- The opportunity is not open to currently enrolled UQ students or students studying at UQ on study abroad or exchange.

Application deadline

30 April for Semester 2 commencement.

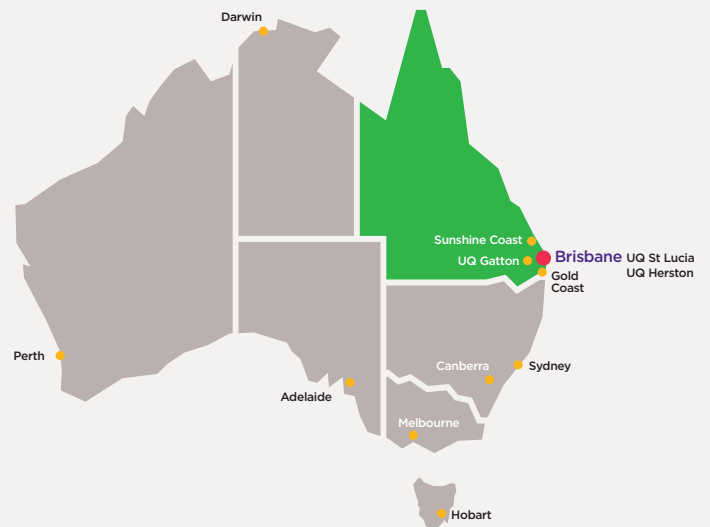
Welcome to Queensland
